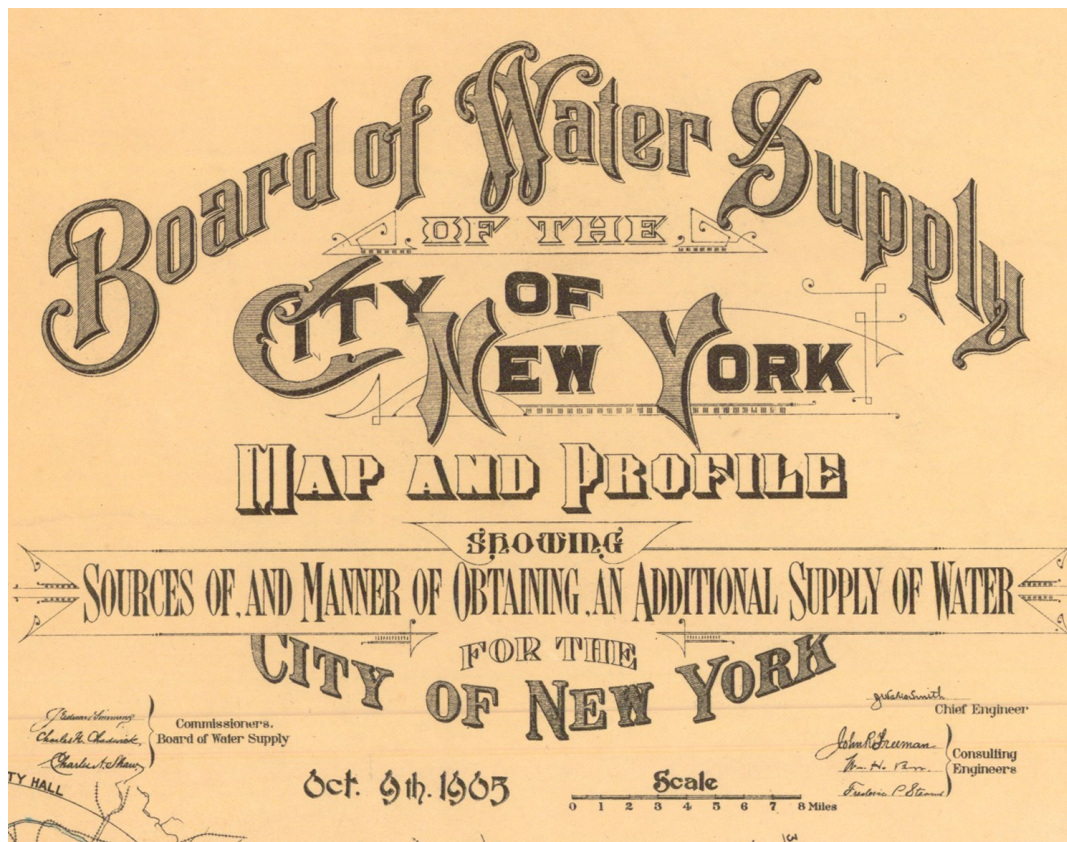

PREFACE

Who were the local residents of the Ashokan Valley? How did the need for water in New York City, at the turn of the century, affect their lives? Why did the landowners file law suits against New York City which lasted almost thirty-six years? What were the law suits about? These questions answered, give evidence to the history surrounding the construction of the Ashokan Reservoir and the impacts of the construction on the local inhabitants.

Ulster County is mandated by law, not only to identify and preserve records of historical value, but also to make available and encourage research of these records in order to add to the knowledge, understanding and appreciation of Ulster County's history.

A guide to the special Records Collection of the Ashokan Reservoir Construction project is an effort by the Ulster County Records Management Program, to bring to interested parties, the records and information that document a part of our County's history.

INTRODUCTION

The Ashokan Reservoir, located in Ulster County, was constructed between the years of 1905 and 1916 for the sole purpose of providing New York City with fresh water. As a result of this monumental project, numerous records were produced to document legal proceedings which took place. Subsequently, these records were filed in the County Clerk's Office.

Utilizing grant funding from the State Archives and Records Administration, Local Government Records Management Improvement Fund, the County Clerk's Office was able to microfilm four separate record series pertaining to the Ashokan Reservoir. These record series are titled, the "Ashokan Reservoir Awards (Transcripts)," "New York City Board of Water Supply – Orders Depositing Money," "New York City Board of Water Supply – Court Orders," and "New York City Board of Water Supply – Orders of Confirmation." (See "Overview of Record Series Description" section)

It is the hope of the Ulster County Clerk that providing user access to this archival information, via the microfilm, will sustain the history of the construction of the Ashokan Reservoir, as well as the permanent impact this project had on the local inhabitants.

ASHOKAN RESERVOIR CONSTRUCTION PROJECT BACKGROUND

The construction of the Ashokan Reservoir was a multimillion dollar project, which in a few short years literally changed the shape of the land and altered its older, established way of life. Never again would Ashokan rest in sleepy rural peace. The aggressive march of urban growth, with its insatiable thirst for pure, fresh water, had reached the Catskill Mountains.

It was in the late 1800's that New York City was experiencing an increase in the need for water. During this time, consumption was increased to approximately 500 million gallons a day. "Water famine," as it was called then, was an ever-pressing problem facing the City of New York.

In 1905, laws were passed creating a regulatory body call the "Water Supply Commission." These laws provided for "...an addition supply of pure and wholesome water for the City of New York; and for the acquisition of lands or interest therein and for the construction of the necessary reservoirs, dams, aqueducts, filters and other appurtenances for that purpose; and for the appointment of a commission with powers and duties necessary and proper to attain these objects."

One of the first acts of the "Water Supply Commission" was to notify property owners whose land would be seized. This was accomplished by publishing a list of names of property owners and numbers which corresponded to parcels of lands cited on a map filed with the County Clerk. The Commission determined that land could be taken ten days after the map was filed, without the owner knowing.

The Commission also determined that the Board of Water Supply would purchase the parcels at one half of the assessed value. The assessed values of lands during 1905 were very low and seldom represented the real value. The following example puts this concept into perspective. Property with a sale value of \$5,000.00 might be assessed for \$500.00 and the owner would receive payment in the amount of \$250.00.

The majority of landowners filed a lawsuit against the City for the unfair treatment of the Board of Water Supply. This litigation lasted almost 36 years and resulted in the creation of 366 volumes of Ashokan Reservoir Awards (Transcripts). These transcripts recorded all Supreme Court Proceedings involving the claimants (landowners) versus the New York City Board of Water Supply.

In addition to the landowners being compensated for their loss of property, the local residents of Ashokan believed they also deserved to be compensated for damages directly relating to the loss of income. The claims included business, indirect real estate (decrease in value of land not taken), wage and diversion (diversion of stream water claims). These claims are located in Business Damage Commission #1 through #5 and are a part of the Ashokan Reservoir Awards (Transcripts).

In the end, the City of New York purchased 21,138 acres in all. Of this amount, 15,222 acres lay in Ashokan and comprise 18 surveyed sections, containing 954 individual parcels of land.

USER GUIDE

The “Overview of Records Series Descriptions,” as well as the “Finding Aids” for each of the four record series on microfilm, have been created in a way that will make it easy for researchers to use.

The “Overview of Records Series Descriptions” lists each of the four record series contained in this collection and informs the user as to the function (purpose) of the record series. Also, included in this section is information relating to the arrangement and indexing (where applicable) of the series.

The “Finding Aid” for the Ashokan Reservoir Awards (Transcripts) was created due to the fact that this series did not contain an index. We also realized that researchers would need a way to access the appropriate roll of microfilm that corresponds to the name of a specific claimant. The logical way to do this was to create an alphabetical index of claimants’ last names and first names and correspond the names to the microfilm roll(s) that would contain the related transcripts. For example, if a user is interested in researching claims made against the Board of Water Supply by Viola Bell, the user would need to take the following steps:

1. Locate the Ashokan Reservoir Awards (Transcripts) Finding Aid within this User Guide.
2. Locate the page within the Finding Aid where “Bell, Viola” would be located alphabetically.
3. Determine from this entry that microfilm roll number 134 is needed to research claims for “Bell, Viola.”
4. Request access to the microfilm roll number 134.

In some cases, the finding aid indicates that more than one roll of microfilm will need to be accessed to research transcripts for one claimant. The user will need to research each roll of microfilm to determine if all rolls pertain to the claimant.

The majority of the 366 volumes of Ashokan Reservoir Awards (Transcripts) do contain index pages within the volumes. These index pages can either be found at the beginning of the volume or dispersed throughout the volume. The index page will list the name and page number within the volume where the transcript begins. (See Attachment A for sample index page)

On the index page, users will find the following abbreviations, D.Ex., C.Ex., R.D. and R.C. These abbreviations stand for the following:

D.Ex. = Direct Examination

C.Ex. = Cross Examination

R.D. = Re-direct

R.C. = Re-cross

With the abbreviations defined, the user can determine, from Attachment A – sample index page, that in the case of Claim James McMillin, the amount claimed was \$10,000.00. Orland E. Ways direct examination testimony begins on page 952. The user can also determine that Fred K. Betts was the witness and his direct examination testimony begins on page 954.

The Ashokan Reservoir Awards (Transcripts) Finding Aid and the index pages found within the individual volumes are the two key tools users need to utilize and locate transcripts for individual claimants.

The Finding Aids for the “Board of Water Supply – Orders Depositing Money,” “Court Orders,” and “Orders of Confirmation” indicate the microfilm roll numbers that contain these record series. Each volume of the above-mentioned records series contains an index in the front. The index is organized alphabetically and indicates a corresponding page number to name. Users need to locate the name and page number and proceed to roll through the film to locate the necessary page numbers.

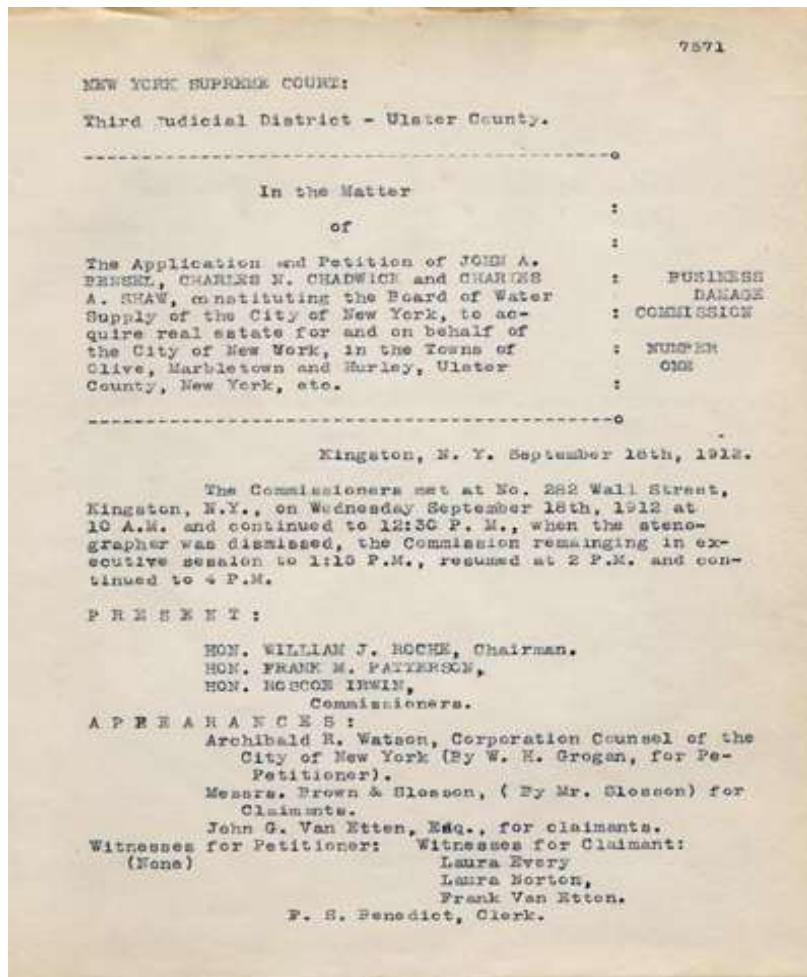

OVERVIEW OF RECORD SERIES DESCRIPTIONS

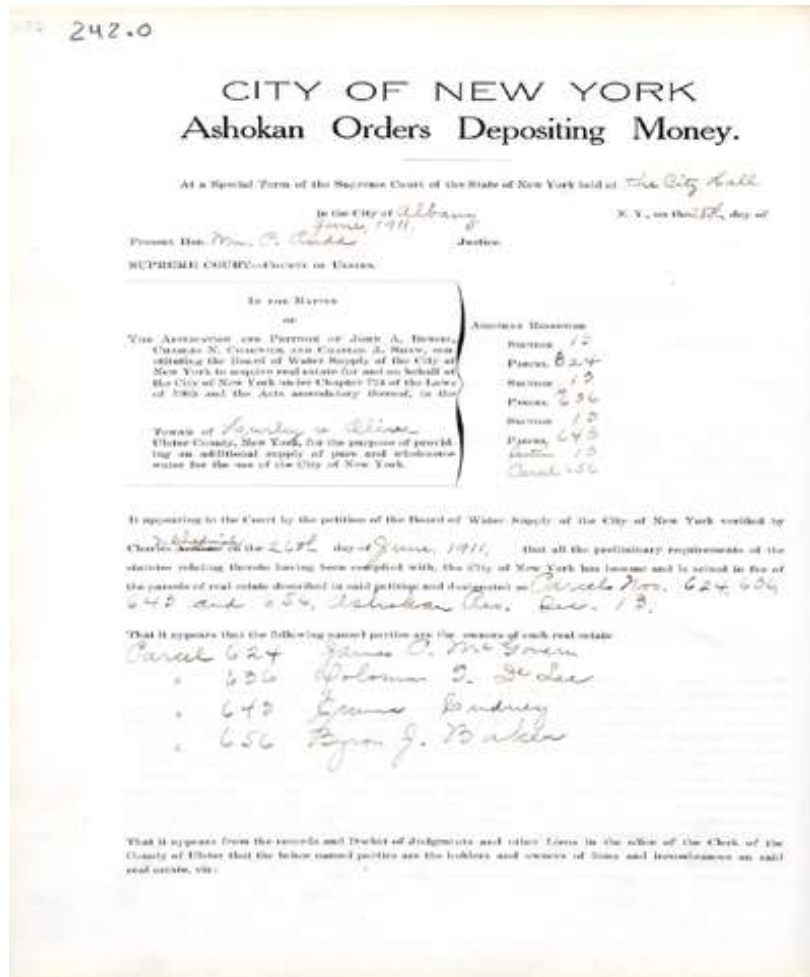
1. ASHOKAN RESERVOIR AWARDS (TRANSCRIPTS)

The Ashokan Reservoir Awards (Transcripts) are comprised of 366 bound volumes of Supreme Court transcripts dating from 1907 through 1942. This record series documents the claims of property and business owners against the City of New York. Information included in this record series indicates County, court, date or hearing, commissioners at hearing, claimant name, amount and nature of claim, witnesses, minutes of proceedings and final disposition of claim. This record series is arranged chronologically by dates of hearings.



2. **NEW YORK CITY BOARD OF WATER SUPPLY – ORDERS**
DEPOSITING MONEY

Orders Depositing Money consist of one bound volume dating from 1908 through 1918 and records orders showing that New York City Board of Water Supply petitioned the Supreme Court and all requirements of law were complied with in seizure of real property under orders of confirmation. Information in this record series includes assessed valuation of property seized, attorney, order of payment in specified depository to credit of property owner, signature of justice and date of order and time of filing. Orders are arranged chronologically by date of recording. This index is located in the beginning of the volume alphabetically by property owner name.

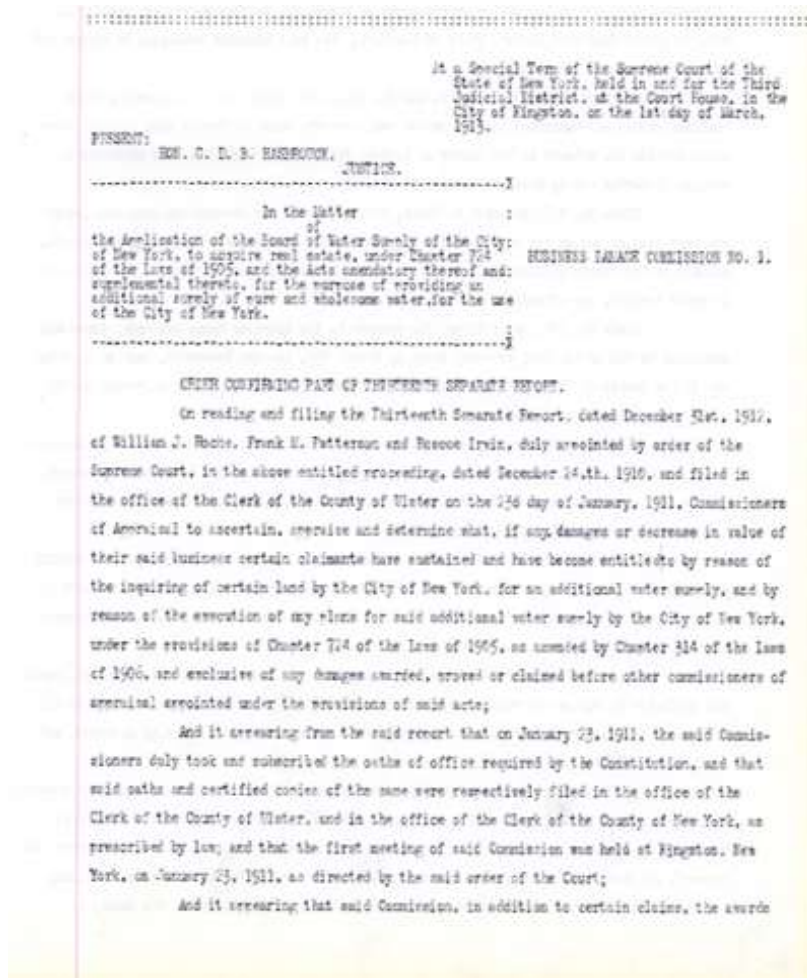


3. **NEW YORK CITY BOARD OF WATER SUPPLY – COURT ORDERS**

Court Orders consist of two bound volumes dating from 1936 through 1958 and contain various recorded orders or special terms of Supreme Court in the matter of New York City's claim of land for reservoir purposes. Orders are arranged chronologically by date of hearings. The index is located in the front of both volumes alphabetically by names of property owners.

4. **NEW YORK CITY BOARD OF WATER SUPPLY – ORDERS OF CONFIRMATION**

Court Orders of Confirmation consist of three bound volumes dating from 1909 through 1948. This record series contains recorded copies of applications and petitions filed by counsel of New York City Board of Water Supply to acquire real estate in Ulster County. In addition, copies of confirmation by Supreme Court of commissioners' reports fixing amount to be paid for property condemned are also included. These orders are New York City's only title to the lands taken. Orders are arranged chronologically by dates of court sessions. The index is located in the front of each volume alphabetically by names of property owners.

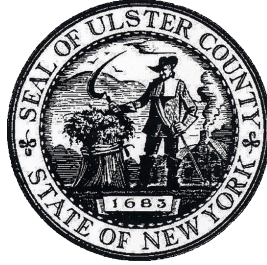
